Authorization and Contract

1) Authorization for Disposition of Cremated Human Remains

I/We, the undersigned, hereby request and authorize Ladies in White, LLC (hereafter Ladies in White) to take possession of and make arrangements for the disposition of the cremated remains of

in accordance with and subject to: a) all applicable federal, state and local laws, b) the terms and conditions set forth in this Authorization and Contract to Scatter Ashes and c) the rules and regulations of Ladies in White.

I/We certify that I/we have the full legal right to authorize the disposition of the remains of the above named Deceased.

2) Contract to Scatter Ashes

Shipping Package Contents I/We certify that the ashes which we shall provide to Ladies in White are those of the above named Deceased and that the package we mail shall contain only ashes, with the exception that I/we may also enclose a letter of farewell and any paperwork and/or payment check as required by Ladies in White.

Payment I/We contract with Ladies in White to scatter the cremated remains of the above named individual in an area I/we specify in the State of Montana and for these services I/we agree to pay Ladies in White \$_____, which payment shall be made in full before the Journey (i.e., the event to scatter the ashes) can be conducted. (To fill in the blank, refer to "Preferences and Pricing Worksheet, page 3, number 8)

Scattering Time Frame and Seasons I/We agree that Ladies in White will scatter the ashes within five weeks from the time my/our check has been received with the exception that weather or other environmental factors may intervene. Forest fires, flooding, early snow in summer or extreme heat may require Ladies in White to act in favor of the health and safety of the Ladies, and I/we understand that Ladies in White will keep us informed and work with us concerning any necessary adjustments to time and place of scattering. I/we understand that Ladies in White do not typically conduct Journeys in winter and that the shipping of ashes should occur by pre-arrangement between April 15th and October 31st.

Photo Record, Certificate, Journal Page I/We understand that once the remains are scattered, they are unrecoverable and I/we agree that Ladies in White has completed its part of this contract with this exception: Ladies in White will provide to me/us a photograph of the general scattering site taken on the day of the Journey as well as four additional photographs taken at points during the Journey, a Certificate documenting the event, and a single page description of the journey. Ladies in White agrees to mail these items no later than two weeks from the completion of the Journey.

Liability I/We agree to release and hold Ladies in White, its employees, successors and assigns harmless from any and all unpreventable loss, damage, liability or causes of action, (including attorney fees and expenses of litigation) in connection with the disposition of the cremated remains of the deceased as authorized herein. Unpreventable loss is understood to include, but not be limited to, loss by the US Postal Service or loss due to act of terrorism or war.

Representation I/We agree that Ladies in White cannot be responsible for inaccurate or misrepresented information provided to them.

Disposal of Urns I/We understand that the container in which we ship the ashes will be disposed of by Ladies in White unless I/we make specific arrangements for its return. I/We ___ do, ___ do not want the shipping container returned to me/us. (If the urn is to be returned, please circle the address below to which you want the urn shipped).

Monuments I/we understand that no monument will be built on the scattering site nor will any token be left at the site. I/we pledge that I/we will not travel to the site at some later time for the purpose of erecting a monument or leaving a token, nor will we cause a monument to be built on or near the site.

Development I/We understand that Ladies in White cannot guarantee that land used for scattering will forever remain undeveloped. I/We understand that although Ladies in White will do its best to select a scattering site that is unsuitable for development, which is not slated for development according to long-range plans, and which has traditionally been protected from development, The Ladies cannot be held to a guarantee.

Special Terms I/We understand that we may add special terms as agreed to in communication with Ladies in White. These special terms apply to commemoration and/or memorialization and are attached.
